HISTORICAL CONTEXT OF DRED SCOTT V. SANDFORD

THE DRED SCOTT CASE EMERGED AGAINST A BACKDROP OF ESCALATING TENSIONS REGARDING SLAVERY IN THE UNITED STATES. AS THE CASE PROGRESSED, IT BECAME EMBLEMATIC OF THE BROADER NATIONAL CONFLICT OVER SLAVERY. THE MISSOURI COMPROMISE, WHICH HAD ATTEMPTED TO MAINTAIN A BALANCE BETWEEN FREE AND SLAVE STATES, WAS UNDER THREAT. THE SUPREME COURT RULING

ON MARCH 6, 1857, THE SUPREME COURT DELIVERED ITS OPINION IN A 7-2 DECISION WRITTEN BY CHIEF JUSTICE ROGER B. TANEY. THE RULING STATED THAT DRED SCOTT WAS NOT A CITIZEN OF THE UNITED STATES AND THEREFORE HAD NO RIGHT TO SUE IN FEDERAL COURT. THE COURT FURTHER DECLARED THAT THE MISSOURI COMPROMISE WAS UNCONSTITUTIONAL, ASSERTING THAT CONGRESS DID NOT HAVE THE AUTHORITY TO PROHIBIT SLAVERY IN THE TERRITORIES.

IMPACT ON AMERICAN SOCIETY

SOCIAL CONSEQUENCES

SOCIALLY, THE RULING REINFORCED THE INSTITUTION OF SLAVERY AND FURTHER MARGINALIZED AFRICAN AMERICANS. IT SIGNALLED TO MANY THAT THEY WOULD HAVE LIMITED LEGAL RECOURSE AGAINST DISCRIMINATION AND INJUSTICE.

LEGAL CONSEQUENCES

LEGALLY, DRED SCOTT V. SANDFORD SET A DANGEROUS PRECEDENT REGARDING CITIZENSHIP AND CIVIL RIGHTS. IT ILLUSTRATED THE SHORTCOMINGS OF THE CONSTITUTION IN PROTECTING THE RIGHTS OF ALL INDIVIDUALS, PARTICULARLY THOSE OF AFRICAN DESCENT.
