

# EM 385 1 1 TRAINING ONLINE

PARTICIPANTS ARE EDUCATED ON THE TYPES OF PERSONAL PROTECTIVE EQUIPMENT REQUIRED FOR VARIOUS TASKS, HOW TO PROPERLY USE AND MAINTAIN PPE, AND THE LEGAL OBLIGATIONS SURROUNDING ITS USE. THIS KNOWLEDGE IS CRUCIAL FOR ENSURING PERSONAL SAFETY AND COMPLIANCE WITH REGULATIONS.

### EMERGENCY RESPONSE PLANNING

THIS COMPONENT FOCUSES ON THE DEVELOPMENT OF EMERGENCY RESPONSE PLANS, INCLUDING EVACUATION PROCEDURES, COMMUNICATION PROTOCOLS, AND THE ROLES OF EMERGENCY RESPONDERS. UNDERSTANDING HOW TO REACT IN EMERGENCIES CAN SAVE LIVES AND MINIMIZE PROPERTY DAMAGE.
