- A: AIM AT THE BASE OF THE FIRE
- S: SQUEEZE THE HANDLE
- S: SWEEP FROM SIDE TO SIDE

TIPS FOR EFFECTIVE STUDYING

STUDYING FOR THE F 01 FIREGUARD EXAM CAN SEEM OVERWHELMING, BUT WITH THE RIGHT STRATEGIES, CANDIDATES CAN ENHANCE THEIR CHANCES OF SUCCESS.

1. CREATE A STUDY SCHEDULE

2. UTILIZE PRACTICE EXAMS

WHILE MEMORIZING FACTS IS ESSENTIAL, UNDERSTANDING THE UNDERLYING CONCEPTS WILL HELP CANDIDATES APPLY THEIR KNOWLEDGE EFFECTIVELY DURING EMERGENCIES AND ON THE EXAM.

IF A FIREGUARD DISCOVERS A FIRE, THEY SHOULD IMMEDIATELY ACTIVATE THE FIRE ALARM, EVACUATE THE AREA, NOTIFY THE FIRE DEPARTMENT, AND USE A FIRE EXTINGUISHER ONLY IF IT IS SAFE TO DO SO.
