- **PATCHES:** FBI PERSONNEL MAY WEAR PATCHES REPRESENTING THEIR UNIT OR DIVISION, WHICH HELPS IN FOSTERING A SENSE OF IDENTITY AND TEAMWORK AMONG AGENTS.

HISTORICAL CONTEXT OF FBI SYMBOLS
