UNDERSTANDING FBI IDENTITY HISTORY SUMMARY

THE FBI IDENTITY HISTORY SUMMARY IS A DOCUMENT THAT PROVIDES A RECORD OF AN INDIVIDUAL'S CRIMINAL HISTORY AS MAINTAINED BY THE FBI. THIS SUMMARY INCLUDES INFORMATION ABOUT ARRESTS, CONVICTIONS, AND ANY OTHER RELEVANT DATA THAT THE FBI HAS ON FILE. INDIVIDUALS CAN REQUEST THIS SUMMARY TO GAIN INSIGHT INTO THEIR OWN RECORDS OR TO PROVIDE IT TO POTENTIAL EMPLOYERS OR AGENCIES AS PART OF A BACKGROUND CHECK.

WHAT IS INCLUDED IN THE SUMMARY?

AN FBI IDENTITY HISTORY SUMMARY CONSISTS OF SEVERAL COMPONENTS:

- **PERSONAL INFORMATION:** THIS INCLUDES THE INDIVIDUAL'S NAME, DATE OF BIRTH, AND ANY ALIASES.
- **ARREST RECORDS:** DETAILED INFORMATION ABOUT ANY ARRESTS MADE, INCLUDING DATES AND CHARGES.
- **CONVICTION RECORDS:** INFORMATION REGARDING ANY CONVICTIONS, INCLUDING THE NATURE OF THE OFFENSE AND SENTENCING DETAILS.
- **DISPOSITION OF CASES:** THIS PROVIDES THE OUTCOME OF THE ARRESTS AND CONVICTIONS.

HOW TO REQUEST AN FBI IDENTITY HISTORY SUMMARY CHECK

FILLED OUT COMPLETELY AND ACCURATELY TO AVOID DELAYS.

STEP 3: WAIT FOR PROCESSING

ONCE YOUR REQUEST IS SUBMITTED, IT MAY TAKE SEVERAL WEEKS FOR THE FBI TO PROCESS IT. THE CURRENT PROCESSING TIMES CAN VARY, SO IT IS ADVISABLE TO CHECK THE FBI'S WEBSITE FOR UPDATES.

COMMON USES OF THE FBI IDENTITY HISTORY SUMMARY
