- **CLASS 7:** RADIOACTIVE MATERIALS
- **CLASS 8:** CORROSIVE SUBSTANCES

- **CLASS 9: MISCELLANEOUS DANGEROUS GOODS**

EACH CLASS HAS SPECIFIC REGULATIONS REGARDING PACKAGING, LABELING, AND SHIPPING REQUIREMENTS TO MITIGATE RISKS ASSOCIATED WITH THESE MATERIALS.
