- **TORTS:** EXAMINES CIVIL WRONGS AND LIABILITY, INCLUDING NEGLIGENCE AND INTENTIONAL TORTS.
- **CRIMINAL LAW AND PROCEDURE:** ADDRESSES SUBSTANTIVE CRIMINAL LAW AND PROCEDURAL SAFEGUARDS IN LEGAL PROCEEDINGS.
- **EVIDENCE:** TESTS KNOWLEDGE OF RULES AND PRINCIPLES GOVERNING THE ADMISSIBILITY OF EVIDENCE IN LEGAL PROCEEDINGS.
- **REAL PROPERTY:** COVERS ISSUES RELATED TO OWNERSHIP, TRANSFER, AND USE OF REAL ESTATE.
- **BUSINESS ASSOCIATIONS:** FOCUSES ON THE LAW GOVERNING VARIOUS BUSINESS ENTITIES, INCLUDING CORPORATIONS AND PARTNERSHIPS.

EACH OF THESE AREAS MAY PRESENT QUESTIONS THAT REQUIRE NOT ONLY KNOWLEDGE OF THE LAW BUT ALSO THE ABILITY TO APPLY LEGAL PRINCIPLES TO HYPOTHETICAL SCENARIOS. CANDIDATES MUST BE PREPARED TO ANALYZE FACTS AND SELECT THE BEST ANSWER FROM PROVIDED OPTIONS.

EFFECTIVE STUDY STRATEGIES FOR THE EXAM
