UNDERSTANDING THE FLS WRITTEN EXAM

EACH SECTION'S WEIGHT MAY DIFFER, AND SOME MAY REQUIRE MORE IN-DEPTH STUDY THAN OTHERS. FOR INSTANCE, PRACTICAL APPLICATION SECTIONS MAY DEMAND HANDS-ON EXPERIENCE OR CASE ANALYSIS PRACTICE, WHILE CORE KNOWLEDGE AREAS MAY RELY MORE ON THEORETICAL UNDERSTANDING.

EFFECTIVE STUDY STRATEGIES
