1. **MAST:** THE VERTICAL ASSEMBLY THAT RAISES AND LOWERS THE LOAD.
2. **FORKS:** THE PRONGED EXTENSIONS THAT LIFT AND CARRY LOADS.
3. **LOAD BACKREST:** A SAFETY FEATURE THAT PREVENTS THE LOAD FROM SLIDING OFF THE BACK OF THE FORKLIFT.
4. **STEERING WHEEL:** CONTROLS THE DIRECTION OF THE FORKLIFT.
5. **BRAKES:** ESSENTIAL FOR STOPPING THE VEHICLE SAFELY.
6. **CONTROLS:** INCLUDES LEVERS AND BUTTONS THAT OPERATE THE FORKLIFT'S FUNCTIONS.

COMMON FORKLIFT TEST QUESTIONS

- USE A SPOTTER TO GUIDE THEM AS THEY NAVIGATE AROUND OBSTACLES.
- IF POSSIBLE, LOWER THE LOAD TO IMPROVE VISIBILITY.

PREPARATION TIPS FOR FORKLIFT TESTS

TO SUCCEED IN YOUR FORKLIFT CERTIFICATION TEST, PROPER PREPARATION IS KEY. HERE ARE SOME TIPS TO HELP YOU GET READY:

1. STUDY THE FORKLIFT OPERATOR'S MANUAL

CERTIFICATION PROCESS

OBTAINING A FORKLIFT OPERATOR CERTIFICATION INVOLVES SEVERAL STEPS:

1. COMPLETE TRAINING

4. RECEIVE CERTIFICATION

ONCE YOU PASS BOTH THE WRITTEN AND PRACTICAL TESTS, YOU WILL RECEIVE A CERTIFICATION CARD. THIS CARD IS PROOF THAT YOU ARE QUALIFIED TO OPERATE A FORKLIFT AND MAY BE REQUIRED BY EMPLOYERS.

COMMON MISTAKES TO AVOID DURING THE TEST

WHAT IS THE MAXIMUM LOAD CAPACITY OF A STANDARD FORKLIFT?

THE MAXIMUM LOAD CAPACITY OF A STANDARD FORKLIFT TYPICALLY RANGES FROM 3,000 TO 5,000 POUNDS, BUT IT CAN VARY BASED ON THE SPECIFIC MODEL.

WHAT TRAINING IS REQUIRED TO OPERATE A FORKLIFT LEGALLY?

OPERATORS MUST COMPLETE A TRAINING PROGRAM THAT COVERS SAFE OPERATION, LOAD HANDLING, AND EQUIPMENT MAINTENANCE, FOLLOWED BY AN EVALUATION TO ENSURE COMPETENCY.
