COMPONENTS OF A FREE ASSET MAPPING TEMPLATE

3. ASSET INVENTORY TABLE

AN INVENTORY TABLE IS A CRUCIAL PART OF THE ASSET MAPPING TEMPLATE. THIS TABLE SHOULD INCLUDE THE FOLLOWING COLUMNS:

- ASSET NAME: THE NAME OF THE ASSET.
- DESCRIPTION: A BRIEF DESCRIPTION OF THE ASSET.

THIS SECTION SHOULD OUTLINE ANY IDENTIFIED GAPS OR NEEDS IN THE COMMUNITY THAT THE ASSETS COULD POTENTIALLY ADDRESS. QUESTIONS TO CONSIDER MAY INCLUDE:

- WHAT ARE THE MOST PRESSING ISSUES FACING THE COMMUNITY?
- HOW CAN EXISTING ASSETS BE LEVERAGED TO MEET THESE NEEDS?
- ARE THERE ADDITIONAL RESOURCES THAT COULD ENHANCE THE EFFECTIVENESS OF THE CURRENT ASSETS?

5. ACTION PLAN

AN ACTION PLAN IS VITAL FOR TRANSLATING THE FINDINGS OF THE ASSET MAPPING INTO PRACTICAL STRATEGIES. THIS SECTION SHOULD INCLUDE:

- GOALS: WHAT THE ORGANIZATION AIMS TO ACHIEVE THROUGH ASSET MAPPING.
- STRATEGIES: SPECIFIC ACTIONS TO LEVERAGE IDENTIFIED ASSETS.
- TIMELINE: A SCHEDULE FOR IMPLEMENTING THE STRATEGIES.
- RESPONSIBILITIES: ASSIGNING ROLES TO INDIVIDUALS OR GROUPS FOR EXECUTING THE ACTION PLAN.

6. EVALUATION METRICS

TO ASSESS THE EFFECTIVENESS OF ASSET MAPPING EFFORTS, ESTABLISH EVALUATION METRICS. CONSIDER INCLUDING:

- NUMBER OF ASSETS IDENTIFIED.
- LEVELS OF COMMUNITY ENGAGEMENT.
- CHANGES IN RESOURCE ALLOCATION.
- IMPACT ON COMMUNITY PROJECTS.

HOW TO UTILIZE A FREE ASSET MAPPING TEMPLATE
