UNDERSTANDING THE GEORGIA GENERAL CONTRACTOR LICENSE

THE GEORGIA GENERAL CONTRACTOR LICENSE IS A LEGAL REQUIREMENT FOR INDIVIDUALS OR BUSINESSES THAT ENGAGE IN CONSTRUCTION ACTIVITIES INVOLVING PROJECTS EXCEEDING \$2,500. THIS LICENSE ENSURES THAT CONTRACTORS MEET SPECIFIC STANDARDS OF SKILL AND KNOWLEDGE, PROVIDING A LEVEL OF PROTECTION FOR CONSUMERS. IN GEORGIA, THERE ARE TWO PRIMARY TYPES OF GENERAL CONTRACTOR LICENSES: THE UNRESTRICTED AND RESTRICTED LICENSES. AN UNRESTRICTED LICENSE ALLOWS CONTRACTORS TO WORK ON ANY SIZE PROJECT, WHILE A RESTRICTED LICENSE LIMITS THE CONTRACTOR TO PROJECTS OF A SPECIFIED SIZE OR SCOPE.

TO MAINTAIN HIGH INDUSTRY STANDARDS, THE STATE REQUIRES ALL CONTRACTORS TO DEMONSTRATE THEIR EXPERTISE THROUGH A STANDARDIZED EXAMINATION. THIS PROCESS HELPS ENSURE THAT ONLY QUALIFIED INDIVIDUALS CAN OPERATE AS GENERAL CONTRACTORS, THEREBY PROMOTING SAFETY AND PROFESSIONALISM WITHIN THE CONSTRUCTION SECTOR.

REQUIREMENTS FOR OBTAINING A LICENSE

BEFORE APPLYING FOR A GENERAL CONTRACTOR LICENSE IN GEORGIA, CANDIDATES MUST MEET SEVERAL REQUIREMENTS. THESE INCLUDE EDUCATIONAL QUALIFICATIONS, WORK EXPERIENCE, AND FINANCIAL RESPONSIBILITY. THE FOLLOWING LIST SUMMARIZES THE KEY REQUIREMENTS:

- **FINANCIAL RESPONSIBILITY:** APPLICANTS MUST PROVIDE PROOF OF FINANCIAL STABILITY, INCLUDING A CREDIT REPORT AND POTENTIALLY A BOND.
- **BACKGROUND CHECK:** A CRIMINAL BACKGROUND CHECK MAY BE REQUIRED.

- BUILDING CODES AND REGULATIONS
- CONSTRUCTION MATERIALS AND METHODS
- PROJECT MANAGEMENT PRACTICES
- SAFETY REQUIREMENTS AND PROTOCOLS
