CORE PRINCIPLES OF GMP

3. PROPER DOCUMENTATION

- VENTILATION: ENSURE ADEQUATE VENTILATION TO DISPERSE FUMES FROM CERTAIN INGREDIENTS OR PROCESSES.
- STORAGE CONDITIONS: STORE RAW MATERIALS AND FINISHED PRODUCTS IN A CONTROLLED ENVIRONMENT TO PREVENT SPOILAGE.

SPECIFIC GUIDELINES FOR SOAP AND COSMETIC HANDCRAFTERS

IN ADDITION TO THE CORE PRINCIPLES OF GMP, HERE ARE SPECIFIC GUIDELINES TAILORED FOR SOAP AND COSMETIC HANDCRAFTERS:

1. FORMULATION AND TESTING

4. HANDLING CUSTOMER COMPLAINTS

HAVING A SYSTEM IN PLACE FOR HANDLING CUSTOMER COMPLAINTS IS VITAL FOR MAINTAINING QUALITY AND TRUST:

- CREATE A COMPLAINT LOG: DOCUMENT ALL CUSTOMER COMPLAINTS, INCLUDING DETAILS AND RESOLUTIONS.
- INVESTIGATE ISSUES PROMPTLY: TAKE CUSTOMER COMPLAINTS SERIOUSLY AND INVESTIGATE ANY REPORTED ISSUES.
- IMPLEMENT CHANGES: USE FEEDBACK TO IMPROVE PRODUCTS AND PROCESSES WHERE NECESSARY.

COMMON MISTAKES INCLUDE NEGLECTING SANITATION PRACTICES, USING UNVERIFIED SUPPLIERS FOR RAW MATERIALS, FAILING TO DOCUMENT PRODUCTION PROCESSES, NOT CONDUCTING QUALITY CHECKS, AND OVERLOOKING LABELING REQUIREMENTS. THESE MISTAKES CAN LEAD TO CONTAMINATION, INCONSISTENT PRODUCT QUALITY, AND POTENTIAL SAFETY ISSUES.
