UNDERSTANDING GRANTS FOR LOGGING BUSINESSES

ORGANIZATIONS FOCUSED ON ENVIRONMENTAL CONSERVATION OR RURAL DEVELOPMENT OFTEN SPONSOR THESE GRANTS.

ELIGIBILITY CRITERIA FOR GRANTS

- BUDGET: PROVIDE A DETAILED BUDGET THAT EXPLAINS HOW GRANT FUNDS WILL BE USED.
- EVALUATION PLAN: DESCRIBE HOW YOU WILL MEASURE THE SUCCESS OF YOUR PROJECT.

IMPORTANCE OF A SOLID BUSINESS PLAN

A COMPREHENSIVE BUSINESS PLAN IS CRITICAL WHEN APPLYING FOR GRANTS TO START A LOGGING BUSINESS. IT NOT ONLY SERVES AS A ROADMAP FOR YOUR BUSINESS BUT ALSO DEMONSTRATES TO GRANTORS THAT YOU ARE SERIOUS AND PREPARED.
