HISTORICAL BACKGROUND OF THE CODE OF ETHICS FOR NURSES

THE CODE OF ETHICS FOR NURSES HAS EVOLVED SIGNIFICANTLY SINCE ITS INCEPTION. THE FIRST FORMAL CODE WAS DEVELOPED IN THE LATE 19TH CENTURY, PRIMARILY INFLUENCED BY THE WORK OF FLORENCE NIGHTINGALE. THE HISTORICAL JOURNEY OF THE NURSING CODE REFLECTS BROADER SOCIETAL CHANGES AND THE INCREASING COMPLEXITY OF HEALTHCARE. AS MEDICAL TECHNOLOGY ADVANCES AND PATIENT RIGHTS BECOME MORE PROMINENT, THE CODE OF ETHICS HAS ADAPTED TO ENSURE THAT NURSES REMAIN ADVOCATES FOR THEIR PATIENTS WHILE UPHOLDING THEIR PROFESSIONAL RESPONSIBILITIES. - **INTEGRITY:** NURSES SHOULD DEMONSTRATE HONESTY AND INTEGRITY IN ALL INTERACTIONS, FOSTERING TRUST IN THE NURSE-PATIENT RELATIONSHIP.
- **PROFESSIONAL COMPETENCE:** CONTINUOUS EDUCATION AND SKILL DEVELOPMENT ARE ESSENTIAL FOR NURSES TO MAINTAIN COMPETENCE AND PROVIDE SAFE, EFFECTIVE CARE.

THESE PRINCIPLES CREATE A FOUNDATION FOR ETHICAL NURSING PRACTICE, ENABLING NURSES TO NAVIGATE COMPLEX SITUATIONS AND MAKE INFORMED DECISIONS. EACH PRINCIPLE IS INTERCONNECTED, REINFORCING THE NOTION THAT ETHICAL NURSING IS A HOLISTIC PRACTICE THAT PRIORITIZES PATIENT WELFARE.

IMPORTANCE OF THE CODE OF ETHICS IN NURSING

ETHICAL NURSING PRACTICE IS VITAL IN FOSTERING POSITIVE RELATIONSHIPS WITH PATIENTS, FAMILIES, AND COLLEAGUES, THEREBY PROMOTING A COLLABORATIVE HEALTHCARE ENVIRONMENT.

PRACTICAL APPLICATIONS OF THE CODE OF ETHICS IN NURSING
