5. WHAT DOES A YELLOW DIAMOND-SHAPED SIGN INDICATE?

A: A YELLOW DIAMOND-SHAPED SIGN WARNS DRIVERS OF POTENTIAL HAZARDS AHEAD, SUCH AS SHARP TURNS, PEDESTRIAN CROSSINGS, OR ROAD WORK.
