UNDERSTANDING HAZMAT AWARENESS

TYPES OF HAZARDOUS MATERIALS

HAZARDOUS MATERIALS CAN BE CATEGORIZED INTO SEVERAL TYPES, EACH PRESENTING UNIQUE RISKS. COMMON CATEGORIES INCLUDE:

KEY REGULATIONS AND STANDARDS
