BACKGROUND ON HELEN HUNT JACKSON

HELEN HUNT JACKSON WAS AN AMERICAN AUTHOR, POET, AND ACTIVIST BORN ON OCTOBER 15, 1830, IN AMHERST, MASSACHUSETTS.
