COMPONENTS OF A HEMODIALYSIS FLOW SHEET TEMPLATE

- HEART RATE: MONITOR FOR ANY ARRHYTHMIAS OR OTHER CONCERNS.
- TEMPERATURE: CHECK FOR SIGNS OF INFECTION OR OTHER COMPLICATIONS.
- WEIGHT: PRE-DIALYSIS AND POST-DIALYSIS WEIGHT MEASUREMENTS TO ASSESS FLUID REMOVAL.

4. LABORATORY RESULTS

- PRE-DIALYSIS LABORATORY VALUES: INCLUDE LEVELS OF UREA, CREATININE, ELECTROLYTES, AND HEMOGLOBIN.
- POST-DIALYSIS LABORATORY VALUES: TRACK CHANGES IN THESE VALUES POST-TREATMENT.

5. TREATMENT PARAMETERS

- DIALYSIS SOLUTION: TYPE OF DIALYSATE USED.
- BLOOD FLOW RATE: THE RATE AT WHICH BLOOD IS PUMPED THROUGH THE DIALYZER.
- DIALYSATE FLOW RATE: THE FLOW RATE FOR THE DIALYSATE.
- ULTRAFILTRATION GOAL: TARGET FLUID REMOVAL FOR THE SESSION.

6. MEDICATIONS ADMINISTERED

- ERYTHROPOIETIN: USED FOR ANEMIA MANAGEMENT.
- IRON SUPPLEMENTS: IMPORTANT FOR PATIENTS WITH CHRONIC KIDNEY DISEASE.
- OTHER MEDICATIONS: DOCUMENT ANY ADDITIONAL MEDICATIONS GIVEN DURING THE DIALYSIS SESSION.

7. COMPLICATIONS AND INTERVENTIONS

- ADVERSE EVENTS: RECORD ANY ADVERSE EVENTS THAT OCCUR DURING TREATMENT, SUCH AS HYPOTENSION OR ALLERGIC REACTIONS.
- INTERVENTIONS: DOCUMENT ANY ACTIONS TAKEN IN RESPONSE TO COMPLICATIONS, INCLUDING MEDICATIONS ADMINISTERED OR ADJUSTMENTS MADE TO TREATMENT.

8. PATIENT EDUCATION AND SUPPORT

- PATIENT'S UNDERSTANDING: NOTE THE PATIENT'S UNDERSTANDING OF THEIR CONDITION AND TREATMENT.
- INSTRUCTIONS GIVEN: DOCUMENT ANY INSTRUCTIONS PROVIDED TO THE PATIENT REGARDING DIET, MEDICATIONS, OR FOLLOW-UP CARE.

DESIGNING AN EFFECTIVE HEMODIALYSIS FLOW SHEET TEMPLATE
