- ANSWER: REPORT THE INCIDENT IMMEDIATELY TO YOUR SUPERVISOR OR THE DESIGNATED PRIVACY OFFICER WITHIN YOUR ORGANIZATION.

HEALTHCARE EMPLOYEES SHOULD UNDERGO HIPAA TRAINING ANNUALLY TO ENSURE THEY ARE UP-TO-DATE WITH THE REGULATIONS AND UNDERSTAND THEIR RESPONSIBILITIES REGARDING PATIENT INFORMATION.

WHAT IS CONSIDERED A BREACH UNDER HIPAA?

A BREACH UNDER HIPAA IS DEFINED AS THE UNAUTHORIZED ACQUISITION, ACCESS, USE, OR DISCLOSURE OF PROTECTED HEALTH INFORMATION THAT COMPROMISES THE SECURITY OR PRIVACY OF THAT INFORMATION.

WHAT STEPS SHOULD BE TAKEN AFTER A HIPAA BREACH?

AFTER A HIPAA BREACH, COVERED ENTITIES MUST NOTIFY AFFECTED INDIVIDUALS, REPORT THE BREACH TO THE DEPARTMENT OF HEALTH AND HUMAN SERVICES (HHS), AND TAKE STEPS TO MITIGATE HARM AND PREVENT FUTURE BREACHES.
