UNDERSTANDING THE COURSE MATERIAL

KEY THEMES IN AMERICAN HISTORY

IDENTIFYING AND UNDERSTANDING KEY THEMES CAN SIGNIFICANTLY ENHANCE A STUDENT'S ABILITY TO RECALL INFORMATION

DURING THE EXAM. SOME OF THE PROMINENT THEMES IN AMERICAN HISTORY THAT MAY BE TESTED INCLUDE:

NATIONAL IDENTITY AND CULTURE

THE EVOLUTION OF AMERICAN NATIONAL IDENTITY IS A RECURRING THEME THROUGHOUT U.S. HISTORY. STUDENTS SHOULD BE PREPARED TO DISCUSS HOW EVENTS SUCH AS THE AMERICAN REVOLUTION, CIVIL WAR, AND VARIOUS WAVES OF IMMIGRATION HAVE SHAPED WHAT IT MEANS TO BE AMERICAN. CULTURAL MOVEMENTS, INCLUDING THE HARLEM RENAISSANCE AND THE BEAT GENERATION, ALSO PLAY A VITAL ROLE IN THIS DISCUSSION.

POLITICAL DEVELOPMENTS

POLITICAL SHIFTS, INCLUDING THE EMERGENCE OF POLITICAL PARTIES, KEY LEGISLATION, AND LANDMARK SUPREME COURT CASES, ARE ESSENTIAL COMPONENTS OF THE CURRICULUM. IMPORTANT LEGISLATION SUCH AS THE CIVIL RIGHTS ACT AND THE VOTING RIGHTS ACT CAN BE FOCAL POINTS FOR EXAM QUESTIONS.

ECONOMIC CHANGES

THE IMPACT OF INDUSTRIALIZATION, THE GREAT DEPRESSION, AND ECONOMIC POLICIES SUCH AS REAGANOMICS ARE CRITICAL IN UNDERSTANDING AMERICA'S ECONOMIC LANDSCAPE. STUDENTS SHOULD BE FAMILIAR WITH HOW THESE FACTORS INFLUENCED SOCIAL CLASSES AND LABOR MOVEMENTS.

- **FLASHCARDS:** USE FLASHCARDS FOR KEY TERMS, DATES, AND SIGNIFICANT FIGURES TO AID MEMORIZATION.

- **GROUP STUDY:** COLLABORATING WITH PEERS ALLOWS FOR DISCUSSION AND CLARIFICATION OF COMPLEX TOPICS.
- **PRACTICE EXAMS:** TAKING PRACTICE EXAMS CAN FAMILIARIZE STUDENTS WITH THE FORMAT AND TYPES OF QUESTIONS THEY MAY ENCOUNTER.
- **REGULAR REVIEW:** CONSISTENTLY REVIEWING MATERIAL HELPS REINFORCE KNOWLEDGE AND REDUCE ANXIETY AS THE EXAM DATE APPROACHES.

QUESTION 3: WHAT IMPACT DID THE CIVIL RIGHTS MOVEMENT HAVE ON AMERICAN SOCIETY?
