INTRODUCTION TO DOMESTIC VIOLENCE

SOCIETAL ATTITUDES TOWARDS DOMESTIC VIOLENCE

HISTORICALLY, DOMESTIC VIOLENCE WAS OFTEN DISMISSED AS A PRIVATE MATTER, LEADING TO UNDERREPORTING AND INADEQUATE LEGAL PROTECTIONS. RECENT DECADES HAVE SEEN A SHIFT IN SOCIETAL ATTITUDES, WITH INCREASING RECOGNITION OF DOMESTIC VIOLENCE AS A PUBLIC HEALTH ISSUE REQUIRING ROBUST INTERVENTIONS. MODERN DEVELOPMENTS

THE WOMEN'S RIGHTS MOVEMENT OF THE 1960S AND 1970S MARKED A SIGNIFICANT TURNING POINT IN THE RECOGNITION OF DOMESTIC VIOLENCE AS A SOCIETAL PROBLEM. EVOLUTION OF THE ICD

THE ICD HAS UNDERGONE SEVERAL REVISIONS SINCE ITS INCEPTION IN 1948, WITH EACH VERSION REFLECTING ADVANCEMENTS IN MEDICAL KNOWLEDGE AND CHANGES IN SOCIETAL ATTITUDES. ICD-10, IMPLEMENTED IN 1994, INCLUDES SPECIFIC CODES FOR DISEASES, DISORDERS, AND INJURIES RESULTING FROM DOMESTIC VIOLENCE. THIS INCLUSION IS CRITICAL FOR IMPROVING THE VISIBILITY OF DOMESTIC VIOLENCE IN HEALTHCARE SETTINGS.

ICD-10 CODES RELATED TO DOMESTIC VIOLENCE

ICD-10 INTRODUCED SPECIFIC CODES THAT ALLOW HEALTHCARE PROVIDERS TO IDENTIFY AND REPORT CASES OF DOMESTIC VIOLENCE SYSTEMATICALLY. THESE CODES FACILITATE THE COLLECTION OF DATA ON THE INCIDENCE AND IMPACT OF DOMESTIC VIOLENCE, ESSENTIAL FOR DEVELOPING TARGETED INTERVENTIONS AND POLICIES.

OVERVIEW OF RELEVANT CODES

- **T74:** ADULT AND CHILD ABUSE, NEGLECT, AND OTHER MALTREATMENT, CONFIRMED.
- **T75:** OTHER EFFECTS OF EXTERNAL CAUSES.
- **F43.1:** POST-TRAUMATIC STRESS DISORDER, WHICH MAY ARISE FROM EXPERIENCES OF ABUSE.

- **F63.0:** PATHOLOGICAL GAMBLING, OCCASIONALLY LINKED TO ECONOMIC ABUSE.

THESE CODES NOT ONLY ASSIST IN THE ACCURATE DOCUMENTATION OF DOMESTIC VIOLENCE CASES BUT ALSO UNDERScore THE NEED FOR COMPREHENSIVE CARE AND SUPPORT FOR VICTIMS. THE SPECIFICITY OF THESE CODES ALLOWS FOR BETTER TRACKING OF TRENDS AND OUTCOMES RELATED TO DOMESTIC VIOLENCE.

UTILIZATION OF ICD-10 IN HEALTHCARE

HEALTHCARE PROVIDERS PLAY A CRITICAL ROLE IN IDENTIFYING AND RESPONDING TO DOMESTIC VIOLENCE. IMPACT OF ICD-10 ON HEALTHCARE PRACTICES

REFINEMENT OF ICD CODING

THIS MAY INVOLVE THE INTRODUCTION OF NEW CODES THAT CAPTURE SPECIFIC FORMS OF ABUSE, SUCH AS ECONOMIC, DIGITAL, OR COERCIVE CONTROL, WHICH ARE INCREASINGLY RECOGNIZED AS CRITICAL COMPONENTS OF DOMESTIC VIOLENCE.
