### 3. DOCUMENTING FINDINGS

AFTER THE ASSESSMENT, THE ASSESSOR WILL DOCUMENT THEIR FINDINGS, WHICH INCLUDES:

- COMPLETING THE UAS FORM, WHICH CAN TAKE SEVERAL HOURS, ESPECIALLY IF THE INDIVIDUAL HAS COMPLEX NEEDS.
- ENSURING ALL INFORMATION IS ACCURATE AND COMPREHENSIVE TO INFORM THE CARE PLAN.

THIS DOCUMENTATION PHASE CAN TAKE ONE TO THREE DAYS, DEPENDING ON THE ASSESSOR'S WORKLOAD.

### 4. CREATING A CARE PLAN

ONCE THE ASSESSMENT IS COMPLETE, THE NEXT STEP IS TO DEVELOP A CARE PLAN BASED ON THE FINDINGS. THIS INVOLVES:
