

# HOW MANY SLIDES IS SB 1343 TRAINING

**HOW MANY SLIDES IS SB 1343 TRAINING?** THIS IS A QUESTION FREQUENTLY ASKED BY ORGANIZATIONS AND INDIVIDUALS PREPARING TO COMPLY WITH CALIFORNIA'S SENATE BILL 1343. THE LEGISLATION AIMS TO PROMOTE A SAFER WORKPLACE BY REQUIRING SEXUAL HARASSMENT PREVENTION TRAINING FOR EMPLOYEES AND SUPERVISORS. UNDERSTANDING THE STRUCTURE AND CONTENT OF THIS TRAINING, INCLUDING THE NUMBER OF SLIDES, IS ESSENTIAL FOR EFFECTIVE IMPLEMENTATION. THIS ARTICLE WILL DELVE INTO SB 1343 TRAINING, ITS REQUIREMENTS, AND THE SIGNIFICANCE OF THE TRAINING MODULES.

## OVERVIEW OF SB 1343

SB 1343 WAS ENACTED IN 2018 AS AN EXTENSION OF PREVIOUS SEXUAL HARASSMENT TRAINING LAWS IN CALIFORNIA. THE PRIMARY OBJECTIVES OF THE BILL ARE TO:

1. ENSURE THAT ALL CALIFORNIA EMPLOYERS WITH FIVE OR MORE EMPLOYEES PROVIDE SEXUAL HARASSMENT TRAINING.
2. MANDATE THAT SUPERVISORS RECEIVE TRAINING EVERY TWO YEARS.
3. REQUIRE THAT ALL EMPLOYEES COMPLETE THEIR TRAINING WITHIN SIX MONTHS OF HIRE OR PROMOTION.

THE LAW EMPHASIZES CREATING A WORKPLACE FREE FROM HARASSMENT AND DISCRIMINATION, THUS FOSTERING A MORE INCLUSIVE AND RESPECTFUL ENVIRONMENT FOR ALL WORKERS.

## TRAINING REQUIREMENTS UNDER SB 1343

TO COMPLY WITH SB 1343, EMPLOYERS MUST PROVIDE SPECIFIC TRAINING THAT INCLUDES THE FOLLOWING COMPONENTS:

- DURATION:
  - SUPERVISORS ARE REQUIRED TO COMPLETE AT LEAST TWO HOURS OF TRAINING.
  - NON-SUPERVISORY EMPLOYEES MUST COMPLETE AT LEAST ONE HOUR OF TRAINING.
- TOPICS COVERED:
  - DEFINITIONS OF SEXUAL HARASSMENT.
  - THE DIFFERENT TYPES OF HARASSMENT (QUID PRO QUO, HOSTILE WORK ENVIRONMENT).
  - STRATEGIES FOR PREVENTING HARASSMENT.
  - INFORMATION ON THE RIGHTS OF EMPLOYEES AND HOW TO REPORT INCIDENTS OF HARASSMENT.

## UNDERSTANDING THE STRUCTURE OF SB 1343 TRAINING

WHEN IT COMES TO THE ACTUAL TRAINING MATERIALS, MANY ORGANIZATIONS UTILIZE SLIDE PRESENTATIONS TO DELIVER CONTENT EFFECTIVELY. THE NUMBER OF SLIDES IN SB 1343 TRAINING CAN VARY DEPENDING ON SEVERAL FACTORS, INCLUDING THE TRAINING PROVIDER, THE DEPTH OF CONTENT, AND THE DELIVERY METHOD.

## TYPICAL SLIDE COUNT AND STRUCTURE

WHILE THERE IS NO LEGALLY MANDATED NUMBER OF SLIDES FOR SB 1343 TRAINING, HERE ARE SOME GENERAL OBSERVATIONS REGARDING TYPICAL TRAINING PRESENTATIONS:

1. FOR SUPERVISOR TRAINING:
  - MOST TRAINING PRESENTATIONS CONSIST OF 30 TO 50 SLIDES.

- INTRODUCTION TO SEXUAL HARASSMENT
- LEGAL DEFINITIONS
- SCENARIOS AND CASE STUDIES
- REPORTING PROCEDURES
- PREVENTION STRATEGIES
- CONCLUSION AND RESOURCES

## 2. FOR NON-SUPERVISOR TRAINING:

- THESE PRESENTATIONS USUALLY CONTAIN 20 TO 30 SLIDES.
- THE STRUCTURE MIGHT INCLUDE:
- OVERVIEW OF SEXUAL HARASSMENT
- EMPLOYEE RIGHTS
- HOW TO REPORT INCIDENTS
- BYSTANDER INTERVENTION TECHNIQUES
- CONCLUSION WITH RESOURCES

THE ACTUAL NUMBER OF SLIDES CAN DIFFER SIGNIFICANTLY BASED ON THE TRAINING PROVIDER. SOME ORGANIZATIONS MAY OPT FOR MORE INTERACTIVE FORMATS, WHICH COULD INCREASE THE SLIDE COUNT AS THEY INCLUDE MORE SCENARIOS, QUIZZES, OR DISCUSSION PROMPTS.

# FACTORS INFLUENCING SLIDE COUNT

SEVERAL FACTORS CAN AFFECT HOW MANY SLIDES ARE INCLUDED IN SB 1343 TRAINING:

## 1. TRAINING PROVIDER

DIFFERENT TRAINING PROVIDERS HAVE THEIR UNIQUE STYLES AND APPROACHES TO CONTENT DELIVERY. SOME MAY PREFER A CONCISE FORMAT, WHILE OTHERS MIGHT TAKE A MORE COMPREHENSIVE APPROACH, LEADING TO A GREATER NUMBER OF SLIDES.

## 2. TRAINING FORMAT

THE FORMAT OF THE TRAINING CAN ALSO INFLUENCE THE NUMBER OF SLIDES. FOR INSTANCE:

- IN-PERSON TRAINING: THIS MAY HAVE FEWER SLIDES, AS TRAINERS CAN ELABORATE ON TOPICS THROUGH DISCUSSION AND ENGAGEMENT.
- ONLINE TRAINING: ONLINE COURSES MIGHT USE MORE SLIDES, INCORPORATING MULTIMEDIA ELEMENTS LIKE VIDEOS, QUIZZES, AND INTERACTIVE SCENARIOS.

## 3. DEPTH OF CONTENT

THE DEPTH AND BREADTH OF THE MATERIAL COVERED WILL DIRECTLY IMPACT THE SLIDE COUNT. A TRAINING MODULE THAT DIVES DEEPLY INTO CASE STUDIES OR INCLUDES EXTENSIVE LEGAL BACKGROUND WILL TYPICALLY HAVE MORE SLIDES THAN A TRAINING SESSION THAT FOCUSES SOLELY ON THE BASICS.

# IMPORTANCE OF EFFECTIVE TRAINING

REGARDLESS OF THE NUMBER OF SLIDES, THE EFFECTIVENESS OF SB 1343 TRAINING HINGES ON SEVERAL KEY FACTORS:

# 1. ENGAGEMENT

ENGAGING TRAINING SESSIONS ARE MORE EFFECTIVE IN PROMOTING UNDERSTANDING AND RETENTION. EMPLOYERS SHOULD LOOK FOR TRAINING PROVIDERS THAT INCORPORATE INTERACTIVE ELEMENTS, SUCH AS:

- GROUP DISCUSSIONS
- ROLE-PLAYING SCENARIOS
- QUIZZES AND ASSESSMENTS

# 2. RELEVANCE

TRAINING CONTENT SHOULD BE RELEVANT TO THE SPECIFIC WORKPLACE ENVIRONMENT AND CULTURE. CASE STUDIES AND EXAMPLES THAT RESONATE WITH EMPLOYEES' EXPERIENCES CAN MAKE THE TRAINING MORE IMPACTFUL.

# 3. FOLLOW-UP AND RESOURCES

PROVIDING FOLLOW-UP RESOURCES AND ACCESS TO ADDITIONAL INFORMATION IS CRUCIAL. EMPLOYERS SHOULD ENSURE THAT EMPLOYEES KNOW WHERE TO GO FOR HELP OR ADDITIONAL TRAINING AFTER THE INITIAL SESSION. THIS COULD INCLUDE:

- ACCESS TO HR RESOURCES
- CONTACT INFORMATION FOR REPORTING HARASSMENT
- LINKS TO RELEVANT POLICIES AND PROCEDURES

# CONCLUSION

IN CONCLUSION, WHILE THE QUESTION OF HOW MANY SLIDES IS SB 1343 TRAINING DOES NOT HAVE A DEFINITIVE ANSWER, IT IS GENERALLY OBSERVED THAT SUPERVISOR TRAINING CONSISTS OF AROUND 30 TO 50 SLIDES, WHILE NON-SUPERVISOR TRAINING HAS ABOUT 20 TO 30 SLIDES. THE SPECIFIC COUNT CAN VARY BASED ON THE TRAINING PROVIDER, THE FORMAT OF THE TRAINING, AND THE DEPTH OF CONTENT COVERED.

ULTIMATELY, THE FOCUS SHOULD NOT SOLELY BE ON THE NUMBER OF SLIDES BUT ON THE QUALITY AND EFFECTIVENESS OF THE TRAINING DELIVERED. BY PROVIDING ENGAGING AND RELEVANT CONTENT, ORGANIZATIONS CAN FOSTER A WORKPLACE CULTURE THAT PRIORITIZES RESPECT AND SAFETY FOR ALL EMPLOYEES, ULTIMATELY FULFILLING THE OBJECTIVES OF SB 1343.

# FREQUENTLY ASKED QUESTIONS

## WHAT IS SB 1343 TRAINING?

SB 1343 TRAINING REFERS TO THE MANDATORY HARASSMENT PREVENTION TRAINING REQUIRED FOR CALIFORNIA EMPLOYERS UNDER SENATE BILL 1343, WHICH AIMS TO EDUCATE EMPLOYEES ABOUT SEXUAL HARASSMENT AND ITS PREVENTION.

## HOW MANY SLIDES ARE TYPICALLY INCLUDED IN SB 1343 TRAINING?

YES, SB 1343 TRAINING CAN BE COMPLETED ONLINE, AND MANY PROVIDERS OFFER INTERACTIVE MODULES THAT CAN INCLUDE SLIDE PRESENTATIONS TO FACILITATE LEARNING.

## WHAT TOPICS ARE TYPICALLY COVERED IN THE SB 1343 TRAINING SLIDES?

TYPICALLY, THE SLIDES COVER TOPICS SUCH AS DEFINITIONS OF SEXUAL HARASSMENT, EXAMPLES OF INAPPROPRIATE BEHAVIOR, REPORTING PROCEDURES, AND THE RIGHTS AND RESPONSIBILITIES OF EMPLOYEES AND EMPLOYERS.
