- REAL ESTATE PROPERTIES
- VEHICLES
- BANK ACCOUNTS
- INVESTMENT ACCOUNTS (STOCKS, BONDS)
- RETIREMENT ACCOUNTS (IRA, 401(K))
- VALUABLE PERSONAL PROPERTY (JEWELRY, COLLECTIBLES)

PROVIDE THE CURRENT MARKET VALUE FOR EACH ASSET. IT'S ESSENTIAL TO BE HONEST AND THOROUGH, AS DISCREPANCIES CAN LEAD TO LEGAL ISSUES LATER.

6. DISCLOSE LIABILITIES

IN THIS SECTION, YOU WILL OUTLINE ANY DEBTS OR LIABILITIES YOU HAVE. COMMON LIABILITIES INCLUDE:

- MORTGAGE BALANCES
- CREDIT CARD DEBTS
- PERSONAL LOANS
- STUDENT LOANS
- ANY OTHER OUTSTANDING DEBTS

BE SURE TO INCLUDE THE TOTAL AMOUNT OWED FOR EACH LIABILITY AND THE MONTHLY PAYMENT YOU ARE MAKING. THIS WILL GIVE THE COURT A FULL UNDERSTANDING OF YOUR FINANCIAL OBLIGATIONS.

7. REVIEW AND SIGN
