UNDERSTANDING THE GEORGIA REAL ESTATE EXAM

THE GEORGIA REAL ESTATE EXAM IS DESIGNED TO ASSESS YOUR KNOWLEDGE AND UNDERSTANDING OF REAL ESTATE PRINCIPLES, LAWS, AND PRACTICES. THE EXAM CONSISTS OF TWO PARTS: THE NATIONAL PORTION AND THE STATE PORTION. THE NATIONAL PORTION COVERS GENERAL REAL ESTATE CONCEPTS APPLICABLE ACROSS THE UNITED STATES, WHILE THE STATE PORTION FOCUSES SPECIFICALLY ON GEORGIA'S REAL ESTATE LAWS AND REGULATIONS.

EXAM FORMAT AND STRUCTURE

THE EXAM IS ADMINISTERED BY PEARSON VUE, AND IT CONSISTS OF A TOTAL OF 152 QUESTIONS. OF THESE, 100 QUESTIONS PERTAIN TO THE NATIONAL PORTION, AND 52 QUESTIONS ARE SPECIFIC TO GEORGIA STATE LAW. JOIN A STUDY GROUP

COLLABORATING WITH PEERS CAN PROVIDE ADDITIONAL INSIGHTS AND SUPPORT. A STUDY GROUP ALLOWS YOU TO DISCUSS COMPLEX TOPICS, QUIZ EACH OTHER, AND SHARE STUDY MATERIALS.

TAKING THE EXAM

AS YOUR EXAM DATE APPROACHES, IT'S ESSENTIAL TO PREPARE FOR THE ACTUAL TESTING EXPERIENCE.

A: YES, MANY LOCAL REAL ESTATE SCHOOLS AND ONLINE PLATFORMS OFFER STUDY GROUPS AND FORUMS WHERE CANDIDATES CAN COLLABORATE AND STUDY TOGETHER.

Q: HOW SOON WILL I RECEIVE MY EXAM RESULTS?

A: YOU WILL TYPICALLY RECEIVE YOUR EXAM RESULTS IMMEDIATELY AFTER COMPLETING THE TEST, THOUGH OFFICIAL RESULTS MAY TAKE A FEW DAYS TO PROCESS.
