# NIRVANA'S ARTISTIC EXPRESSION AND THE "I HATE MYSELF AND WANT TO DIE" LYRICS

NIRVANA, AND PARTICULARLY ITS FRONTMAN KURT COBAIN, WERE KNOWN FOR THEIR INTROSPECTIVE AND OFTEN BLEAK LYRICAL CONTENT.
