UNDERSTANDING THE CONSTITUTION

THE ARTICLES

THE AMENDMENTS

THE CONSTITUTION HAS BEEN AMENDED TWENTY-SEVEN TIMES SINCE ITS RATIFICATION. THE FIRST TEN AMENDMENTS, KNOWN AS THE BILL OF RIGHTS, WERE ADOPTED IN 1791 AND ARE PARTICULARLY SIGNIFICANT AS THEY GUARANTEE FUNDAMENTAL RIGHTS AND LIBERTIES TO INDIVIDUALS. SUBSEQUENT AMENDMENTS HAVE ADDRESSED VARIOUS ISSUES, INCLUDING CIVIL RIGHTS, VOTING RIGHTS, AND GOVERNMENT PROCEDURES.
