Pappe highlights the deliberate destruction of villages and the expulsion of their residents as clear evidence of ethnic cleansing.

Pappe meticulously reconstructs these campaigns, often using military communiques and eyewitness accounts to illustrate the systematic nature of the expulsions and the violence that accompanied them.

Methods of Coercion and Intimidation
