- MUST BE AT LEAST 21 YEARS OLD.
- MUST BE A U.S. CITIZEN OR LEGAL RESIDENT.
- MUST POSSESS A VALID FIREARM OWNER'S IDENTIFICATION (FOID) CARD.
- MUST HAVE COMPLETED A STATE-APPROVED TRAINING COURSE.
- MUST NOT HAVE A FELONY CONVICTION, A VIOLENT MISDEMEANOR CONVICTION, OR A HISTORY OF MENTAL HEALTH ISSUES.

APPLICATION PROCESS

THE APPLICATION PROCESS CONSISTS OF SEVERAL STEPS:

1. **OBTAIN A FOID CARD:** BEFORE APPLYING FOR A CONCEALED CARRY LICENSE, ENSURE THAT YOU HAVE A VALID FOID CARD.
2. **COMPLETE THE REQUIRED TRAINING:** COMPLETE A 16-HOUR TRAINING COURSE FROM A STATE-APPROVED INSTRUCTOR. THIS COURSE WILL COVER FIREARM SAFETY, THE LAWS REGARDING THE USE OF FORCE, AND BASIC HANDGUN MARKSMANSHIP.
3. **PREPARE YOUR APPLICATION:** GATHER NECESSARY DOCUMENTATION, INCLUDING YOUR FOID CARD NUMBER, PROOF OF TRAINING COMPLETION, AND A RECENT PASSPORT-STYLE PHOTOGRAPH.
4. **SUBMIT YOUR APPLICATION:** APPLICATIONS CAN BE SUBMITTED ONLINE THROUGH THE ILLINOIS STATE POLICE (ISP) WEBSITE OR VIA MAIL. ENSURE THAT YOU PAY THE APPLICABLE FEES (CURRENTLY \$150 FOR A 5-YEAR LICENSE).
5. **AWAIT BACKGROUND CHECK:** THE ISP CONDUCTS A THOROUGH BACKGROUND CHECK ON ALL APPLICANTS, WHICH CAN

TAKE UP TO 90 DAYS.

6. **RECEIVE YOUR LICENSE:** IF APPROVED, YOU WILL RECEIVE YOUR CONCEALED CARRY LICENSE IN THE MAIL.

TRAINING REQUIREMENTS

TRAINING IS A CRUCIAL ASPECT OF OBTAINING A CONCEALED CARRY LICENSE IN ILLINOIS. THE 16-HOUR TRAINING COURSE MUST COVER SPECIFIC TOPICS MANDATED BY THE STATE.

COURSE CONTENT

THE TRAINING PROGRAM WILL TYPICALLY INCLUDE THE FOLLOWING COMPONENTS:

- **FIREARM SAFETY:** UNDERSTANDING THE FUNDAMENTALS OF FIREARM SAFETY TO PREVENT ACCIDENTS.

WHEN SELECTING A TRAINING PROVIDER, CONSIDER THE FOLLOWING:

- ENSURE THEY ARE STATE-APPROVED AND HAVE A GOOD REPUTATION.
- LOOK FOR REVIEWS OR TESTIMONIALS FROM FORMER STUDENTS.
- INQUIRE ABOUT THE INSTRUCTOR'S EXPERIENCE AND QUALIFICATIONS.
- CONSIDER THE LOCATION AND SCHEDULING OPTIONS TO MATCH YOUR AVAILABILITY.

RENEWAL OF CONCEALED CARRY LICENSE

ONCE YOU OBTAIN YOUR CONCEALED CARRY LICENSE, IT IS ESSENTIAL TO UNDERSTAND THE RENEWAL PROCESS. THE LICENSE IS VALID FOR FIVE YEARS, AND THERE ARE SPECIFIC STEPS TO FOLLOW FOR RENEWAL.

RENEWAL PROCESS

THE RENEWAL PROCESS INCLUDES:

1. **APPLY FOR RENEWAL:** SUBMIT YOUR RENEWAL APPLICATION TO THE ISP, INCLUDING YOUR FOID NUMBER AND ANY REQUIRED DOCUMENTATION.
2. **COMPLETE TRAINING (IF REQUIRED):** AS OF THE CURRENT LAWS, YOU MAY NEED TO COMPLETE A 3-HOUR RENEWAL TRAINING COURSE.

4. **AWAIT PROCESSING:** SIMILAR TO THE INITIAL APPLICATION, THE ISP WILL CONDUCT A BACKGROUND CHECK, AND PROCESSING MAY TAKE UP TO 90 DAYS.

IMPORTANCE OF RENEWAL

FAILURE TO RENEW YOUR CONCEALED CARRY LICENSE BEFORE IT EXPIRES MAY LEAD TO PENALTIES, INCLUDING FINES OR A COMPLETE LOSS OF YOUR ABILITY TO CARRY CONCEALED. IT IS RECOMMENDED TO START THE RENEWAL PROCESS AT LEAST A FEW MONTHS BEFORE YOUR LICENSE EXPIRES.

WHERE YOU CAN CARRY

UNDERSTANDING WHERE YOU CAN LEGALLY CARRY A CONCEALED FIREARM IN ILLINOIS IS VITAL FOR RESPONSIBLE GUN OWNERSHIP.

PERMITTED LOCATIONS

IN ILLINOIS, YOU CAN CARRY A CONCEALED FIREARM IN MOST PUBLIC PLACES, INCLUDING:

- PARKS AND RECREATIONAL AREAS.
- STORES AND SHOPPING CENTERS.
- PUBLIC TRANSPORTATION.
- RESTAURANTS (UNLESS THEY SERVE ALCOHOL).

PROHIBITED LOCATIONS

HOWEVER, THERE ARE SEVERAL LOCATIONS WHERE CARRYING A CONCEALED FIREARM IS PROHIBITED:

- SCHOOLS AND DAYCARE FACILITIES.
- GOVERNMENT BUILDINGS AND PUBLIC TRANSPORTATION FACILITIES.
- PRIVATE PROPERTY WHERE FIREARMS ARE PROHIBITED (E.G., PRIVATE HOMES OR BUSINESSES).
- PLACES OF WORSHIP (UNLESS PERMITTED BY THE RELIGIOUS ORGANIZATION).

LEGAL CONSEQUENCES OF CONCEALED CARRY

FAILURE TO COMPLY WITH ILLINOIS CONCEALED CARRY LAWS CAN LEAD TO SERIOUS LEGAL REPERCUSSIONS.

PENALTIES FOR VIOLATIONS

POSSIBLE PENALTIES INCLUDE:

- FINES AND LEGAL FEES, WHICH CAN QUICKLY ACCUMULATE.
- SUSPENSION OR REVOCATION OF YOUR CONCEALED CARRY LICENSE.
- CRIMINAL CHARGES, WHICH MAY RESULT IN A FELONY CONVICTION.

BEST PRACTICES FOR RESPONSIBLE CARRYING

- STAY INFORMED ABOUT LOCAL LAWS AND REGULATIONS.

- PRACTICE SAFE HANDLING AND STORAGE TECHNIQUES.
- BE MINDFUL OF YOUR SURROUNDINGS AND THE PEOPLE AROUND YOU.
