APPLICATION PROCESS FOR THE LICENSE EXAM

ONCE EDUCATIONAL REQUIREMENTS ARE MET, THE NEXT STEP IS TO APPLY FOR THE NAIL TECHNICIAN LICENSE EXAM. THE PROCESS INCLUDES SEVERAL STEPS:

EXAM STRUCTURE AND CONTENT

TO PASS THE PRACTICAL EXAM, CANDIDATES MUST DEMONSTRATE PROFICIENCY IN THESE SKILLS WHILE ADHERING TO SAFETY AND SANITATION PROTOCOLS.

PREPARATION TIPS FOR THE EXAM

4. TAKE MOCK EXAMS

IF AVAILABLE, TAKE MOCK EXAMS TO FAMILIARIZE YOURSELF WITH THE FORMAT AND TYPES OF QUESTIONS YOU MAY ENCOUNTER. THIS WILL HELP REDUCE ANXIETY AND IMPROVE YOUR TEST-TAKING SKILLS.

AFTER THE EXAM: NEXT STEPS

HOW IS THE ILLINOIS NAIL TECHNICIAN LICENSE EXAM STRUCTURED?

THE ILLINOIS NAIL TECHNICIAN LICENSE EXAM CONSISTS OF A WRITTEN PORTION AND A PRACTICAL PORTION. THE WRITTEN EXAM TESTS KNOWLEDGE OF NAIL CARE, HYGIENE, AND SAFETY, WHILE THE PRACTICAL EXAM ASSESSES THE CANDIDATE'S HANDS-ON SKILLS IN PERFORMING NAIL SERVICES.

CANDIDATES TYPICALLY RECEIVE THEIR EXAM RESULTS WITHIN A FEW WEEKS AFTER COMPLETING BOTH THE WRITTEN AND PRACTICAL PORTIONS OF THE ILLINOIS NAIL TECHNICIAN LICENSE EXAM.

WHAT SHOULD I BRING ON THE DAY OF THE ILLINOIS NAIL TECHNICIAN LICENSE EXAM?

ON THE DAY OF THE EXAM, CANDIDATES SHOULD BRING A VALID PHOTO ID, ANY REQUIRED MATERIALS FOR THE PRACTICAL EXAM (SUCH AS TOOLS AND PRODUCTS), AND CONFIRMATION OF THEIR EXAM APPOINTMENT.

WHAT HAPPENS IF I FAIL THE ILLINOIS NAIL TECHNICIAN LICENSE EXAM?

IF A CANDIDATE FAILS EITHER PORTION OF THE ILLINOIS NAIL TECHNICIAN LICENSE EXAM, THEY MAY RETAKE THE EXAM. SPECIFIC GUIDELINES AND WAITING PERIODS FOR RETAKING THE EXAM CAN BE FOUND ON THE IDFPR WEBSITE.
