WHAT IS CRIMINAL PSYCHOLOGY?

 - A MASTER'S OR DOCTORAL DEGREE IN PSYCHOLOGY, WITH A FOCUS ON FORENSIC PSYCHOLOGY OR CRIMINAL PSYCHOLOGY.
- LICENSING: MOST STATES REQUIRE PSYCHOLOGISTS TO BE LICENSED, WHICH INVOLVES PASSING THE EXAMINATION FOR PROFESSIONAL PRACTICE IN PSYCHOLOGY (EPPP) AND FULFILLING SUPERVISED EXPERIENCE REQUIREMENTS.
- SPECIALIZED TRAINING: MANY FORENSIC PSYCHOLOGISTS PURSUE ADDITIONAL TRAINING IN AREAS SUCH AS CRIMINAL LAW, ETHICS, AND SPECIFIC PSYCHOLOGICAL ASSESSMENTS.

ESSENTIAL SKILLS FOR FORENSIC AND CRIMINAL PSYCHOLOGISTS

- EMPATHY AND SENSITIVITY: UNDERSTANDING THE EMOTIONAL AND PSYCHOLOGICAL IMPACT OF CRIME ON VICTIMS AND OFFENDERS.
- RESEARCH SKILLS: CAPABILITY TO CONDUCT AND EVALUATE RESEARCH STUDIES RELEVANT TO CRIMINAL BEHAVIOR AND PSYCHOLOGY.

APPLICATIONS OF FORENSIC AND CRIMINAL PSYCHOLOGY

THE APPLICATION OF FORENSIC AND CRIMINAL PSYCHOLOGY IS VAST AND VARIED, IMPACTING MULTIPLE AREAS WITHIN THE CRIMINAL JUSTICE SYSTEM:
