 - "HOW CAN YOU INCORPORATE MENTAL HEALTH SUPPORT INTO HER OVERALL CARE PLAN?"

SIGNIFICANCE OF JANET RILEY iHUMAN QUESTIONS IN NURSING EDUCATION

THE JANET RILEY iHUMAN QUESTIONS SERVE SEVERAL ESSENTIAL PURPOSES IN NURSING EDUCATION:

ENHANCING CRITICAL THINKING SKILLS
