JCPENNEY HAS SPECIFIC DELIVERY WINDOWS THAT VENDORS MUST ADHERE TO. DELIVERIES OUTSIDE THESE WINDOWS MAY BE SUBJECT TO REFUSAL OR DELAYS. VENDORS SHOULD CONSULT THE GUIDE FOR THE EXACT TIMEFRAMES APPLICABLE TO THEIR SHIPMENTS.

LABELING REQUIREMENTS

CORRECT LABELING IS CRUCIAL FOR ENSURING THAT SHIPMENTS ARE PROCESSED EFFICIENTLY WITHIN JCPENNEY'S DISTRIBUTION SYSTEM.

1. LABEL FORMAT
